

1. AGREEMENT TO TERMS

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Advanced Symbolics (2015) Inc. (“Company”, “we”, “us”, or “our”), concerning your access to and use of the app.askpolly.ai website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). We are registered in Canada and have our registered office at 109 York St., Ottawa, Ontario K1N 5T4. You agree that by accessing the Site, you have read, understood, and agree to be bound by all of these Terms and Conditions. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS AND CONDITIONS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms and Conditions at any time and for any reason. We will alert you about any changes by updating the “Last updated” date of these Terms and Conditions, and will provide Customer with notice of the changes. Please ensure that you check the applicable Terms every time you use our Site so that you understand which Terms apply. You will be subject to, and will be deemed to have been made aware of and to have accepted, the changes in any revised Terms and Conditions by your continued use of the Site after the date such revised Terms and Conditions are posted.

The information provided on the Site is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject us to any registration requirement within such jurisdiction or country. 7. OPTIONAL SUPPORT SERVICES

8. TERMINATION

14. SITE MANAGEMENT

19. DISPUTE RESOLUTION

Binding Arbitration

You and the company will use their best efforts to informally settle disagreements regarding this agreement. If unsuccessful, the dispute will be settled through a confidential arbitration by a single arbitrator under the Ontario Arbitration Act. The arbitration will be held in Ottawa, Ontario. The decision of the arbitrator will be final and binding and cannot be subject to appeal. The arbitrator shall have the authority to grant any remedy the arbitrator deems just, including specific performance, interim, interlocutory, and permanent injunctive relief, damages, interest and costs. Nevertheless, nothing in this provision shall limit the jurisdiction of the Ontario Superior Court of Justice conferred by sections 6, 7 and 8 of the Arbitration Act. Notwithstanding the foregoing, either party may elect to bring a claim before the Ontario Small Claims Court, for matters within its jurisdiction. Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity, or termination, shall be referred to and finally resolved by the International Commercial Arbitration Court under the European Arbitration Chamber (Belgium, Brussels, Avenue Louise, 146) according to the Rules of this ICAC, which, as a result of referring to it, is considered as the part of this clause. The number of arbitrators shall be three (3). The seat, or legal place, of arbitration shall be Ottawa, Canada. The language to be used in the arbitral proceedings shall be English. The governing law of the contract shall be the substantive law of Canada.

Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.
